MINUTES OF A SPECIAL MEETING

BOARD OF DIRECTORS OF THE MADRID COMMUNITY SCHOOL DISTRICT

WEDNESDAY, JANUARY 5, 2022

Call to Order

The Board of Directors for the Madrid Community School District met for a special meeting on Wednesday, January 5, 2022 in the Madrid Administration Office. Meeting was called to order by President Lauren Clark at 5:00pm.

Roll Call

Members present were Allie Antonovich, Chelcie Badgley, Lauren Clark, and Jessica Smith. Tyler Simmons arrived at 5:09pm. Superintendent Brian Horn, Board Secretary Kris Van Pelt, and two other guests were also in attendance.

Special Meeting Agenda for January 5, 2022

Moved by Antonovich, second by Badgley to approve the special meeting agenda for January 5, 2022 as presented. Roll call: Badgley, Smith, Antonovich, Clark. Motion carried 4-0.

First Reading and Immediate Implementation

On Friday December 17th, the U.S. Court of Appeals for the Sixth Circuit dissolved the stay order on the OSHA Emergency Temporary Standard (ETS) mandating vaccinations/testing for employers with 100 or more employees. Because the stay order has been dissolved, OSHA has stated they intend to begin enforcing the ETS beginning January 10th. However, the testing requirements will not be enforced until February 9th. Affected districts

are encouraged to continue working closely with their legal counsel to confirm the plans and processes for carrying out the requirements of this rule will fully comply with the law. The decision by the Sixth Circuit has already been appealed to the U.S. Supreme Court, and the outcome of this case could change once again.

Policy 403.7 – Employee Vaccination/Testing for COVID-19 is a mandatory policy for districts which employ 100 or more employees, regardless of full time or part time status. This policy was developed by the Iowa Association of School Boards, is supported by Ahlers Law Firm and has been provided as the recommendation to approve, along with the policy regulations and exhibits.

After board discussion, a motion by Badgley was made to approve policy 403.7, policy regulations and exhibits to help the district comply with these requirements. Smith seconded the motion. Roll call vote: Ayes: Simmons, Smith, Antonovich, Badgley, Clark. Motion carried 5-0.

Adjournment

There was no further business to come before the Board for consideration at this time. Moved by Antonovich, second by Badgley to adjourn the meeting. Roll call: Smith, Antonovich, Badgley, Simmons, Clark. Motion carried 5-0. President Clark adjourned the meeting at 5:21pm.
