Explanation of significant increases in the budget:

The City is decreasing the actual tax asking for the employee benefits and liability insurance. Since the taxable valuations went up by \$ 8,069,695 it increased the Regular General (\$8.10 levy dollars) by \$65,365 which accounts for the 5.01% change. The actual rate is going from \$12.89 per \$1,000 valuation to \$12.29.
